- 2018-2019 End of Year Report: Dr. Kate Alice presented board with end of year report that provided an overview of school culture, EOG ELA and Science results, student retention, discipline, attendance rate, and enrollment.
- 2019-2020 Enrollment Update 166 new students via Lotterease. Total expected enrollment on the first day of school is 426.

- EOG Results: Champions who scored level 3 or higher

  - 4<sup>th</sup> Grade ELA 34%
  - 5<sup>th</sup> Grade ELA 39%
  - 5<sup>th</sup> Grade Science 60%
  - 6<sup>th</sup> Grade ELA 43%
  - 7<sup>th</sup> Grade ELA 54%
  - 8<sup>th</sup> Grade ELA − 51%
  - 8<sup>th</sup> Grade Science 66%

Math scores are delayed until August.
